1. Call to Order

Chair Peterson called the meeting to order at 3:00 pm.

2. Roll Call

Chair Peterson took the roll; a quorum was confirmed.

3. Approve Agenda

Commissioner Schmitt moved approval of the agenda. Second by Commissioner Branstad. Motion adopted.

4. Approve Minutes

Commissioner Johnson moved approval of the February 25, 2025 meeting minutes. Second by Commissioner Bertram. Motion adopted.

5. Treasurer's Report and Financial Statement

Chair Peterson provided a report on the current MRC financials. Anne Kilzer noted there have been questions about dues in 2026; this will be discussed at the October Business Meeting but as of now no increases are anticipated unless brought forward by members. Commissioner Anderson made a motion to file the Treasurer's Report and Financial Statement. Second by Commissioner Olson. Motion adopted.

6. Speaker: Representative Mike Wiener

Representative Wiener thanked the Board of Directors and Britta Torkelson for the invitation to speak. He has been an advocate for rural communities at the Capitol and stressed the importance of Commissioners making their perspective heard. Discussion included unfunded mandates, tax relief, health care, reporting requirements, PILT. Representative Wiener encouraged members to reach out to relevant Committee Chairs in addition to their own representatives. MRC members also shared frustration with agency rulemaking processes.

7. Legislative Updates and Discussion

Britta Torkelson provided an update on current status of House and Senate leadership, and upcoming special elections. She also gave an overview of the MRC Platform development process which will take place at the October Business Meeting.

8. Round Robin/Top of Mind Issues

Members provided updates about top-of-mind issues and successes within their counties. Each one also provided information regarding their levy amounts for 2026. Topics discussed included staffing/negotiations, land use/water quality/drainage, facilities/construction projects, waste, energy,

libraries, and housing.

9. Announcements/Other

Chair Peterson noted that the date for the next meeting is incorrect on the agenda; it will be held on October 6 (not 7) in Alexandria in the Commissioner's Board Room. Anne Kilzer added that this will be in person only, a hybrid option will not be available. Anne welcomed Nobles County to MRC and noted that Clearwater County has also joined.
